

**SUMMARY ANNUAL REPORT FOR
THE SAINT LOUIS UNIVERSITY WELFARE BENEFIT PLAN**

This is a summary of the annual report of The Saint Louis University Welfare Benefit Plan (Employer Identification Number 43-0654872, Plan Number 518) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Saint Louis University has committed itself to pay certain medical, Scholarship (funded), healthcare FSA (medical, dental and vision) claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Life Insurance Company of North America, Delta Dental of Missouri, Reliastar Life Insurance Company, Vision Service Plan, National Union Fire Ins. Co. of Pittsburgh, PA and MetLife Legal Plans to pay certain life, accidental death and dismemberment, dental, vision, long-term disability, accident, business travel accident and legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$4,204,988.
